




This portfolio focuses on capturing long-term capital appreciation and generating consistent income through high dividend yielding equities listed in European markets.



Long-Term Focus: This is a buy-and-hold strategy, aiming to benefit from compounding returns on both capital appreciation and reinvested dividends over time.


Country Breakdown




Sector Breakdown
